## **Summary Annual Report for UA Local 190 SUB Plan**

This is a summary of the annual report for UA Local 190 SUB Plan (“Plan”), a plan providing supplemental unemployment benefits, Employer Identification Number 23-7116328, plan number 502, for period June 1, 2021 to May 31, 2022.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Joint Board of Trustees has committed itself to pay certain supplemental unemployment benefit claims incurred under the terms of the Plan.

### **Basic Financial Statement**

The value of Plan assets, after subtracting liabilities, was \$1,589,128 as of May 31, 2022, compared to \$1,341,685 as of June 1, 2021. During the plan year, the Plan experienced an increase in its net assets of \$247,443. This increase includes unrealized appreciation or depreciation in the value of Plan assets; that is the difference between the value of the Plan’s assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The Plan had total income of \$509,643, which included employer contributions of \$507,737, employee contributions of \$0, realized gains of \$0 from the sale of assets, and \$1,906 in earnings from investments.

Plan expenses were \$262,200. These expenses included \$53,204 in administrative expenses and \$208,996 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

The charge to cover copying costs, given above, does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan, 30700 Telegraph Road, Suite 2400, Bingham Farms, Michigan 48025 and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor, upon payment of copying costs.
